

# **Privacy policy and cookies**

#### 1. Data Administrator

The administrator of the data of the users of the website <a href="www.historyland.pl">www.historyland.pl</a> ("Service") is PTT Invest Limited Liability Company established In Cracow, Rynek Główny 28 Street, 31-010 Cracow, signed in to the register of entrepreneurs run by the District Court for Cracow-Midtown in Cracow, 11th Division Commercial Register of the National Court Register under number KRS: 0000539678, under tax ID number: 6762483951 and the REGON number: 360611621 ("HistoryLand").

## 2. What data are processed?

We process user data related to standard use of the **Service**.

When a user connects to the Service, in our systems appears the information about the number (IP address), type of user device as well as many other information considering connection:

- query time;
- time to reply;
- user station name;
- information about the user's web browser;
- error information that occurred during the http connection;
- URL of the page previously visited by the user, if entering on site was due to the outside link or referring connection.

Detailed rules of data processing in connection with the sale of tickets or complaints are set out in the Online Ticket Sales Regulations.

# 3. To what extent do we process the above data?

The aforementioned information will be processed for technical purposes of ensuring proper functioning of the Service and for analytical and statistical purposes. Based on this information and other data that we own, HistoryLand is not able to identify a single user.

Personal data or user information may be made available to third parties or authorities in accordance with the law. We may entrust the processing of personal data and user information to third parties, in particular for the purpose of servicing the Service.

### 4. Cookies

We also use cookies and similar solutions within the Service. Cookies are small text files that are sent by the Service to your device and stored in its memory.

We use cookies, among other things in order to:

- ensuring the smooth functioning of the Service;
- customize the Service to your needs, including by saving it preferences and settings;



- providing ads tailored to the including those displayed on

user's preferences and behavior, other websites;

- statistical and analytical.

Cookies also use tools we use within the Service, such as Google Analytics (Privacy Policy - here http://www.google.com/analytics/learn/privacy.html) and Facebook (Cookie Policy - here https://www.facebook.com/policies/cookies/).
